Town of Carbonado Regular Session of the Town Council Monday, January 13th, 2020

CALL TO ORDER

The meeting was opened at 6:30 p.m. by Mayor Vesey.

ROLL CALL

PLEDGE OF ALLEGIANCE

Mayor Vesey led those in attendance of the council meeting in the Pledge of Allegiance.

COUNCILMEMBER EXCUSAL

Mayor Vesey asked for a motion to excuse the absence of Councilmember David Rodway.

Council Action: A motion was made by Councilmember Argo to excuse the absence of Councilmember David Rodway. The motion was seconded by Councilmember Sandin and carried 3-0.

CONSENT AGENDA

Approval of the January 13th, 2020 Agenda.

Approval of the minutes from the December 9th, 2019 Council meeting.

TREE HARVESTING

Councilmember Argo explained that when the Town gives an easement, it doesn't give permission to the grantor to cut any trees down and it doesn't allow them to put a utility easement either. It's strictly to use the property as an easement to get to and from the property. He'd like to know what the Town can do to make sure the property owners are going by the easement contracts and what the Town needs to do when they break the easement contract.

Councilmember Argo would also like to revisit the discussion of harvesting the trees on the railroad that are worth money and the hazardous ones. He'd like the clerk to get an estimate for a timer cruiser to come and reassess the value of the timer. Discussion will be continued when there is a full Council.

RMSA GRANT THROUGH AWC

Clerk Treasurer informed the Council that the Town applies for a \$5000.00 safety grant through AWC. She asked if the Council had any ideas and gave a few examples of past grants given. Council would like to see the Town apply for more streetlights.

SCHOLARSHIP – ELLIE HICKLE

Mayor Vesey asked for a motion to grant a one time, \$1000.00 scholarship, to Ellie Hickle.
