BUILDING INSPECTOR

Dean Munday thanked the Council for his 38 years of employment and stated that he was retiring at the end of December 2020. He introduced the new Building Inspector, Joel Ward, to the Council. Mr. Mundy stated that Joel knew of a grant that might help the town upgrade to online services for building permits and go paperless. He also stated that he thought Joel would be a great fit for the Town.

Council Action: A motion was made by Councilmember Sandin to add Fire Chief Eric Skogen to the Mastercard account with a \$5000.00 limit and to add Tavis Argo to the Mastercard account with a \$500.00 limit and both must sign the credit card agreement form from the Town. The motion was seconded by Councilmember Emry and carried 5-0.

OLD BUSINESS:

TREE HARVESTING

Mayor Vesey asked the Council if they would like to set a workshop date to discuss with the Forester the options for possible tree harvesting after the Forester returns home in April. The Council asked the Deputy Clerk to find a date that works for the Forester after he returns in April but before the May councilmeeting.

MAYOR

PUBLIC WORKS

Kaleb Murphy was not present to give the Council an update so Councilmember Argo let the Council know about the vandalism that was done recently at the Watershed Springline. He stated that someone made several breaks in the pipes spanning about 850 feet. He stated that the Town needs to get signs stating No Trespassing, Watershed property and that it's a Federal Offense for trespassing and or tampering with property. He also stated that the Deputy Clerk had filed a report with the Pierce County Sherriff's Department and they were going to be calling the Insurance company to see what they will cover. He recommends that the Town replaces the broken pipes with heavier duty pipes and put them underground. Discussion followed.

CLERK-TREASURER

Deputy Clerk, Sandi Carlson, informed the Council that the town was recently audited by the Department of Retirement Systems and while the town had no findings, they did have a potential issue found. It stated that the town did not advise the elected officials of their option to join the membership. Sandi stated that she had asked them why that was an issue since the elected officials don't qualify for Retirement since they don't have enough hours. The answer given was that the town doesn't have the responsibility to determine if an elected official meets eligibility, the town only has the responsibility to inform the elected officials that they have the option to join membership. The elected officials can reach out to DRS to learn more

She also informed the Council that Joe Sprouse had emailed her asking if the Town would be willing to get a snowplow attachment and that the Fire Department would possibly pay for it. Discussion followed. The Council decided it was more of a liability to plow the streets than to just leave them. They also stated they don't have something to attach it to anyways. Sandi stated that she had been in discussion with Pierce County to see if it would be cost effective to have them plow Pershing when they were done with the Wilkeson-Carbonado road. She will email them again and update Council at the next meeting.
