Town of Carbonado Regular Session of the Town Council Monday, August 8, 2022

CALL TO ORDER

The meeting was opened at 6:30 p.m. by Mayor Vesey.

ROLL CALL

Councilmembers present: Councilmember Tom Argo, David Rodway, Clint Emry, JJ Sandin and Terry Carter.

PLEDGE OF ALLEGIANCE

Mayor Vesey led those in attendance of the council meeting in the Pledge of Allegiance.

PUBLIC HEARING

Mayor Vesey opened the Public Hearing at 6:30 p.m. regarding Resolution No. 363, regarding the Six-Year Transportation Improvement Plan From 2023-2028.

Mayor Vesey opened the floor for public comment. Scott Hubbard stated he was concerned if the trail was to get paved, ATVs would use it as a road. Jessie Sprouse commented that she agreed with Scott and was also concerned that if the trail was paved that the city could lose out on money by paving the trail and not selling it to Rails to trails. Sandi Carlson stated that she would recommend that this portion of trail remains unpaved due to lots of equestrian use and once it's paved, it's hared to keep moss off and that the maintenance isn't worth it.

Mayor Vesey closed the Public Hearing regarding Resolution No. 363, regarding the Six-Year Transportation Improvement Plan From 2023-202 at 6:37 p.m.

PUBLIC HEARING

Mayor Vesey opened the Public Hearing at 6:37 p.m. regarding Ordinance No. 516, amending Ordinance No. 490 and 513 to remove the prohibition on land subdivision in the instance where a private well can be provided.

Mayor Vesey opened the floor for public comment. Scott Hubbard stated he does not support Ordinance No. 516 because there is potential for future developers to put in a large number of homes. He stated he was concerned how it would impact the school and fire department. He also stated that Unincorporated Pierce County does not allow for any building under a 5 acre parcel. Jessie Sprouse mentioned that the school really has no plan B if the Council moves forward with this ordinance as is. She says the school district would have to move into the White River School District and realistically, where would the kids go? Wilkeson is pretty full already so we'd really need to discuss where our kids would go. Sandi Carlson reminded the Council that they don't have to make any changes to current ordinance to allow subdivisions. She said the Council does have the power to keep Carbonado small. Councilmember Argo asked if the Carbonado School could look into downsizing their district area.

Mayor Vesey closed the Public Hearing regarding Ordinance No. 516, amending Ordinance No. 490 and 513 to remove the prohibition on land subdivision in the instance where a private well can be provided at 7:09 p.m. Mayor Vesey then opened the regular Council meeting at 7:09 p.m.
