Public Works Lead, Pendergast, informed the council of the need for a wireless communication device for the fire alarm and auto dialer at the water plant. She explained that the phone line that is currently in place, through CenturyLink, has not been working for months. She presented to council a cost proposal and asked for permission to order it. Discussion followed
